**7. Public Comments on Items Not on the Agenda**

*Staff from the Office of Supervisor Matt LaVere advised Saticoy MAC members that an informational presentation by the City of Ventura had been proposed for inclusion during Public Comment; however, Staff was unable to properly add the item for a revision of the agenda in a timely manner. The proposed presentation pertains to a City of Ventura project. Upon discussion, the council determined that the informational presentation should be placed on the Saticoy MAC agenda for the February meeting. City of Ventura staff agreed.*

**8. Community/Government Reports and Announcements**

- a. Beat Report from California Highway Patrol in Ventura County  
*No report was delivered by CHP.*
- b. Beat Report from County of Ventura Sheriff's Office  
*A new Ventura County Sheriff's Office Beat Deputy has been assigned to the Saticoy area from the Ventura Patrol Headquarters Station. Deputy Austin Whittaker introduced himself and reported that crime, graffiti, and vandalism levels have remained low. He further advised that community patrols are ongoing throughout the area and recommended that residents keep vehicles free of visible items and ensure vehicles are locked when unattended.*

**9. Council Action Items – *Action***

- a. Recommendation of Chair Sunner to elect a Chair and Co-Chair for the Staff  
*advised the Council that this item was duplicate and had already been addressed under Item No. 5.*

**10. Sub-Committee Update on Community Outreach and Engagement - *Action***

- a. Continuation – July 7, 2025: Discussion on Establishing a Benefit Assessment District to Fund Alley Paving in Unincorporated Saticoy; and Expanding Community Service Area No. 14 to Provide and Finance Street-Sweeping Services in Support of the Saticoy Municipal Advisory Council's Goal of Cleaner, Safer Streets.  
*Council Member Sunner moved that the Council approve a draft support letter describing the Saticoy MAC's proposal to pursue a Benefit Assessment to pave the alleyway in Saticoy, including language regarding media outreach and the process for the implementation of a survey to assess interest in paying for the construction of a paved alleyway through a Benefit Assessment.*

Motion Carried: 5-0*

- b. Update on the Saticoy Welcome Sign – Selection of options and community input.  
*Council Member Joshua Addison moved that the Council dismiss the proposed Welcome Sign proposal and instead establish an Ad Hoc Committee to discuss and propose a mural on the Caltrans wall located at Highway 118 and Wells Road. The motion was seconded by Chair Jacqueline Flores to recognize the Ad Hoc Mural Art Committee, with Council Members Joshua Addison and Laura Dunbar designated as steering members, and to direct the committee to report back to the Saticoy MAC on its ongoing efforts.  
Motion Carried: 5–0*
