*Project Description: A mixed-use development consisting of 49-unit apartment building, a 10,000 square foot market and Gas Station, a 4,000 square foot fast service drive-thru dining establishment with two commercial tenants, and a 2,355 square foot fast service drive-thru dining establishment within the City of Ventura at the southeast corner of Darling Road and Wells Road.*

*City of Ventura, Senior Planner delivered a presentation to the Saticoy MAC regarding a City of Ventura project locate at Wells and Darling Road known as East Village Center*

The items were presented to the council with a final version to be reported back to the council in March or April meetings.*

b. Update on the Saticoy Welcome Sign – Selection of options and community input. *Council Members Joshua Addison and Laura Dunbar were designated as steering members with efforts to partner with Caltrans Public Art team and mobilize efforts for a community mural at sound wall located at SR 118 (Wells Rd). Clerk made comments on efforts and will provide more information to report back to Saticoy MAC on its ongoing efforts.*
