Ron Solarzano comments One Book One Coast: The summer reading program features "*They Called Us Enemy*" by George Takei and runs from June 1 to August 1, 2026, across all county libraries; comments on the Ojai Library Friends and Foundation hosting a book sale at the Ojai Library; and comments the Oak View Library will serve free lunch to youth ages 18 and under, Monday through Thursday, from July 7–31 between 12:30 and 1:30 p.m.

Ojai Police Chief Abbott comments the Ojai Police Department along with the City of Ojai hosted an educational E-bike safety forum on Wednesday, May 6th; comments about 30 people were in attendance; and comments on hosting another forum along with a bike rodeo in the future.

7. City of Ojai Planning Commission Update.

Brad Stewart, Ojai Planning Commission, reported on the Ojai Planning Commission's review of the development of a five-unit low-income housing development located at 408-410 N. Montgomery in Ojai; reported on Ojai Planning Commission's review of the Green Coalition development of the ECO Center Master Plan; reported on Ojai Planning Commission's review of the City's Draft of Objective Design Standards for Multifamily and Mixed-Use housing; and reported on Ojai Planning Commission's review of the 2045 General Plan Safety Element addressing the City's Very High Fire Hazard Severity Zone.

8. Review of Camp Gilga Conditional Use Permit Application, Case No. PL25-0039.

Noe Torres, with the Ventura County Planning Division, gave a presentation.

Council members had comments and questions about the camp operations and who it will serve, how campers will arrive, cars and/or bus. Questions about the length of the CUP term. Questions regarding weather tree protections will be in place during construction.

Susan Curtis, Ventura County Planning Division Interim Director, notes at the direction of the Board of Supervisors, planning is reviewing CUP term limits overall. Planning staff stated tree protection is addressed in the conditions of approval.

Barbara Kennedy comments on delaying the light from red to green at Oak View Ave, to allow for cars to turn left out of Short Street onto Hwy 33; comments on holding a Community Emergency Response Team (CERT) meeting in the fall; and comments on the Oak View Memorial Day parade.
